

#### Housing Committee Approves LD 772 to Promote Permitting Predictability

The Joint Select Committee on Housing recently voted to pass LD 772, sponsored by Senator Matt Pouliot, to promote permitting predictability. This bill was submitted as an initiative of MEREDA's Public Policy Committee and could significantly improve the landscape for real estate permitting in Maine. The Committee is currently in the process of finalizing language to ensure their intent is reflected in the final draft, and MEREDA is working with them on that effort. When finalized, LD 772 would:

- Lock in existing land use ordinances for municipal land use applications on the date by which the project is publicly noticed for consideration by the municipal land use authority.
  - The date of public notice was chosen as the vesting date because it is an easily identifiable moment in time by which the municipality has functionally deemed the application to be complete and acknowledged that it is ready for review on the basis of the underlying ordinance.
- Promote housing creation and protect the hard work of city staff and elected officials who entertain significant public input and consideration both during the comprehensive planning process that guides the policies within ordinances, and the enactment of the actual ordinances themselves. Planning, growth strategies, economic development, and community cohesion are all important factors that go into shaping a town's ordinances, and a developer should be able to rely on the adopted standards once they are in place.

#### More Money for Housing!

MEREDA is supporting the Maine Affordable Housing Coalition (MAHC) in its efforts to encourage the Housing Committee and the Appropriations and Financial Affairs (AFA) to consider adding an additional one-time allocation of \$20 million to support affordable housing programs, including affordable home ownership.

- Governor Mills has currently proposed \$10 million for the Maine State Housing Authority to put toward new housing units through the Affordable Homeownership Program, to expand affordable energy-efficient housing options that are affordable to works and support state workforce needs.
- The housing community generally feels that something on the order of \$500 million in state investment will ultimately be required to meet the state's significant housing needs.
- ◆ The additional \$20 million allocation would come out of \$107 million set-aside from the stated allocations in the Governor's proposed supplemental.

#### Maine Historic Tax Credit - Opportunities to Expand!

Two bills, LDs 2106 and 1810 are looking at expanding the Maine Historic Tax Credit.

- LD 2106, sponsored by Sen. Rotundo and endorsed by MAHC, would raise the project cap on substantial projects to allow developers to complete projects in fewer phases and promote project completion; and
- LD 1810, sponsored by Rep. Maureen Terry, would expand the small-project set-aside to improve uptake of the program similar to recommendations made by OPEGA during its review of the credit program in 2022.

MEREDA supports both bills and is eager to see how the Taxation Committee finalizes their reports to the legislature. If both bills are approved by the legislature, they would need further approval from the Appropriations and Financial Affairs Committee to appropriate the money necessary to effectuate the programs. We will be pushing out an advocacy alert to MEREDA members when the time is right!
